# **ORDER DIRECTING RESPONSES**

Issue Date: May 15, 2025 Effective Date: May 15, 2025 On March 21, 2025,<sup>1</sup> Evergy Metro, Inc. d/b/a Evergy Missouri Metro (EMM) filed eight tariff sheets with a proposed effective date of April 21, 2025. The tariff sheets were assigned Tracking No. JE-2025-0134.

On April 15, the Staff of the Commission (Staff) requested that the Commission suspend the tariff sheets and direct Staff to file a recommendation. The Commission subsequently suspended the tariff sheets until June 20, 2025, and directed Staff to file a recommendation.

On May 14, Staff filed its recommendation. Staff stated it could not recommend approval.

The Commission will set a time for responses to Staff's recommendation.
