ORDER APPROVING TARIFFS

Issue Date: May 16, 2025

Effective Date: May 28, 2025

On May 7, 2025, the Commission issued its *Report and Order* (Order) that, among other things, rejected tariff sheets filed by Missouri-American Water Company (MAWC) on July 1, 2024, and authorized MAWC to file tariff sheets that comply with the Order.

On May 12, 2025, MAWC filed revised tariff sheets designed to comply with the Order. The tariff sheets bear an effective date of June 11, 2025, and have been assigned Tracking Numbers JW-2025-0157 and JS-2025-0158.

Also on May 12, 2025, MAWC filed a *Motion for Expedited Treatment and Approval of Compliance Tariffs* in which it asks the Commission to approve the tariff sheets to take effect on May 28, 2025, or as soon as thereafter as practicable. MAWC states that good cause exists to approve the tariffs on less than 30 days' notice in that the tariffs have been filed in compliance with the Order, the Commission and the public have been aware of MAWC's rate increase request for over ten months, the rate case process has enabled the Commission and the parties to consider all aspects of the request and the possible impact of a rate increase, and because the operation of law date for this case is May 28, 2025.

On May 15, 2025, the Staff of Commission filed its *Staff Recommendation to Approve Tariffs* stating that it has reviewed the proposed tariff sheets and recommends the Commission approve them. The Commission received no other responses to MAWC's tariff filing or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. MAWC's Motion for Expedited Treatment is granted.
2. The revised tariff sheets filed by MAWC on May 12, 2025, and assigned Tracking Numbers JW-2025-0157 and JS-2025-0158, are approved to be effective on May 28, 2025. The approved tariffs are:
