ORDER REGARDING PREHEARING CONFERENCE AND FILING OF PROCEDURAL SCHEDULE

Issue Date: May 20, 2025 Effective Date: May 20, 2025

On May 7, 2025,¹ the Commission granted three applications to intervene and ordered Staff of the Commission (Staff) to file a joint procedural schedule for all of the parties no later than May 20. On May 14, one additional party was granted intervention. On May 15, the Office of the Public Counsel (OPC) filed its *Request for a Prehearing Conference* (Request). OPC's Request states that OPC believes "it is important for the intervenors to understand their rights and duties in front of the Commission."

The Commission cannot instruct parties on how to present their case. However, Chapter 536, RSMo. sets forth the basics of contested case procedure. Chapter 386, RSMo. contains several provisions regarding PSC hearings. Further, the Commission Rules regarding practice before the Commission can be located at 20 CSR 4240 Chapter 2. Although Commission Rule 20 CSR 4240-2.130 requires specific formatting for prepared testimony, unrepresented parties will only be expected to file coherent, legible testimony in EFIS as described in the Commission's May 7th order.

On May 20, Staff filed its *Motion for Extension* (Motion) requesting an extension to May 29. The Motion, indicates that the parties are engaging in discussions on the procedural schedule and that no parties objected to this request.² The Commission finds this request reasonable and will grant the extension.

- 1. OPC's Request for a Prehearing Conference is denied.
- 2. Staff's Motion for Extension is granted.
- 3. Staff shall file a joint procedural schedule for all parties no later than May 29.
 - 4. This order shall be effective when issued.
