

ORDER CANCELING PREHEARING CONFERENCE

On November 27, 2000, the Commission issued an order that scheduled a prehearing conference for January 3, 2001. The purpose of the prehearing conference was to facilitate discussions among the parties about a procedural schedule, test year and true-up proposals. On December 29, Missouri Gas Energy (MGE), acting on behalf of all the parties, filed a Recommended Procedural Schedule, Test Year and Notice of Local Public Hearings and Motion to Cancel Prehearing Conference.

With the filing of the agreed upon procedural schedule and test year, the need for the January 3, 2001 prehearing conference has been eliminated.

IT IS THEREFORE ORDERED:

1. That the Prehearing Conference scheduled for January 3, 2001 is canceled.

2. That this order shall become effective on January 3, 2001.


