SUSPENSION ORDER

On November 7, 2000, Missouri Gas Energy (MGE) submitted to the Commission proposed tariff sheets intended to implement a general rate increase for natural gas service provided to its Missouri customers. The proposed tariffs were assigned Tariff No. 200100529. On November 27, the Commission issued a Suspension Order and Notice that suspended the submitted tariff sheets until October 6, 2001.

On December 28, MGE filed a pleading entitled Missouri Gas Energy's Resubmission of Certain Tariff Sheets and Motion to Suspend. That pleading indicates that MGE inadvertently failed to include certain tariff sheets with its November 7 tariff filing. Those tariff sheets were listed on the cover letter that accompanied the November 7 filing but the sheets were left out of the packet of tariff sheets that were filed with the Commission. MGE's pleading indicates that it learned of the omission through conversations with the Staff of the Commission.

On December 28, along with its pleading, MGE filed the previously omitted tariffs sheets, bearing an effective date of January 27, 2001. Because these tariff sheets are intended to be a part of the November 7 rate case tariff filing, MGE requests that the additional tariff sheets be

suspended for the same period as the tariff sheets that were filed on November 7.

The Commission has considered the tariffs filed on December 28 along with MGE's pleading. The Commission concludes that the tariffs should be suspended until October 6, 2001.

IT IS THEREFORE ORDERED:

1. That the tariff sheets (Tariff File No. 200100697) submitted on December 28, 2000, by Missouri Gas Energy, are hereby suspended until October 6, 2001. The tariff sheets so suspended are specifically identified as:
