**JOINT MOTION TO SUSPEND PROCEDURAL SCHEDULE**

**COMES NOW** Union Electric Company d/b/a Ameren Missouri ("Company" or "Ameren Missouri"), Staff of the Missouri Public Service Commission ("Staff"), the Office of Public Counsel ("OPC"), and Missouri School Boards' Association ("MSBA"), (collectively "Joint Movants") and for their Joint Motion to Suspend Procedural Schedule, state as follows:

1. Staff, the Company, OPC, and MSBA have reached agreement on the terms of a settlement that resolves all issues in this case. Joint Movants are working to reduce the agreed-upon terms to a formal stipulation and agreement for filing with the Commission over the next week.
2. Under the modified Procedural Schedule, the hearings begin on June 9, 2025. Given the settlement, no need exists for the hearings and briefing.
3. Consequently, Joint Movants request that the Commission promptly issue an order suspending the Procedural Schedule.
