MOTION OF THE STAFF, PUBLIC COUNSEL AND MISSOURI GAS ENERGY FOR PARTIAL SUSPENSION OF PROCEDURAL SCHEDULE

Come now the Staff of the Missouri Public Service Commission ("Staff"), the Office of the Public Counsel ("Public Counsel") and Missouri Gas Energy ("MGE"), a division of Southern Union Company, by and through counsel, and for this motion for partial suspension of procedural schedule respectfully state the following:

- 1. Since the conclusion of the prehearing conference, the Staff, Public Counsel and MGE have been able to reach agreement in principle which they believe will resolve almost all of the issues in this proceeding. The Staff, Public Counsel and MGE are working to file a Stipulation and Agreement with the Commission as soon as possible, possibly by the close of business on June 8, 2001, and in any event no later than June 12, 2001.
- 2. The Staff, Public Counsel and MGE respectfully suggest that limited resources are better devoted to finalizing a Stipulation and Agreement than preparing surrebuttal testimony on what are believed to be settled issues. Therefore, the Staff, Public Counsel and MGE suggest that it would be reasonable to suspend the procedural schedule (e.g., the filing of surrebuttal testimony, the preparation of position statements and the scheduling of hearing time) as to those issues which are believed to be settled. At this point in time, the only issues which the Staff, Public Counsel and MGE believe

remain in dispute are 1) class cost-of-service/class revenue responsibility and 2) the low-income fixed credit tariff rate proposed by Public Counsel.

Wherefore, the Staff, Public Counsel and MGE respectfully requests that the Commission suspend the procedural schedule concerning all issues except those as set forth in paragraph 2, above. If agreement is not reached as planned the Staff, OPC and MGE will inform the Commission immediately and propose a new schedule for the filing of surrebuttal testimony so that the hearing may proceed as scheduled.
