## ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On April 15, 2025, The Empire District Electric Company d/b/a Liberty filed its *2024 Annual Renewable Energy Standard Compliance Report* (Report) and its *2025 Annual Renewable Energy Standard Compliance Plan* (Plan), as required by Commission Rule 20 CSR 4240-20.100(8). Commission Rule 20 CSR 4240-20.100(8)(D) requires the Staff of the Commission (Staff) to review renewable energy standard (RES) compliance reports and plans and file a report of its review with the Commission within 45 days of the date of filing.<sup>1</sup>

On May 30, 2025, the Staff of the Commission filed its *Report and Request for Extension*. Staff requests an additional five days to discuss its concerns with Liberty before finalizing its report, and to file another pleading. Liberty agrees to the extension.

The Commission finds the request reasonable, and will grant it.

### THE COMMISSION ORDERS THAT:

1. The Request for Extension is granted.
