**ORDER RECOGNIZING NAME CHANGE**

Issue Date: May 20, 2025

Effective Date: June 1, 2025

On May 8, 2025, the Commission received a request from Kingdom Telephone Company and Kingdom Telephone Company d/b/a Kingdom Long Distance to recognize its name change to Kingdom Telephone Company d/b/a Kingdom Networks. The company also requested the Commission approve the submitted adoption notices and revised tariff title sheet, assigned Tracking Nos. JI-2025-0155 and JX-2025-0154. The submitted adoption notices and revised tariff title sheet all have an effective date of June 1, 2025.

Additionally, Kingdom Telephone Company stated its intent to withdraw its tariff PSC Mo. No. 3 (wireless termination tariff) as it has no customers under that tariff. The withdrawal of the tariff was assigned Tracking No. JI-2025-0156.

The Commission has reviewed the filings and 20 CSR 4240-28.011(2), and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission will recognize the name change and approve the adoption notices and revised tariff title sheet. The Commission will also approve the withdrawal of

Kingdom Telephone Company's wireless termination tariff, PSC Mo. No. 3, assigned Tracking No. JI-2025-0156.

So that the adoption notices and revised tariff title sheet become effective on the date requested, the Commission finds it reasonable for this order to become effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the name change of Kingdom Telephone Company and Kingdom Telephone Company d/b/a Kingdom Long Distance to Kingdom Telephone Company d/b/a Kingdom Networks.

2. The Commission approves the adoption notices and revised tariff title sheet, assigned Tracking Nos. JI-2025-0155 and JX-2025-0154, to become effective on June 1, 2025, as follows:
