On June 2, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed a revised tariff sheet, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism (DSIM) Rider. The tariff sheet bears an effective date of August 1, 2025, and has been assigned Tracking No. JE-2025-0171.

Commission Rule 20 CSR 4240-20.093(4) requires the Staff of the Commission (Staff) to examine and analyze the information Evergy Missouri Metro has filed and to submit a recommendation no later than 30 days after Evergy Missouri Metro filed its tariff revision.

The Commission will establish a deadline for the filing of applications to intervene and direct its Data Center to serve a copy of this order upon the parties in Case No. EO-2023-0369 and upon the county commission of each county in Evergy Missouri Metro's service area. In addition, the Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving Evergy Missouri Metro's service area.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall add all parties from Case No. EO-2023-0369 to the service list for this case.

2. The Commission's Data Center shall serve a copy of this order upon the county commission of each county in Evergy Missouri Metro's service area.

3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the news media serving the residents of Evergy Missouri Metro's service area.

- 4. Any applications to intervene shall be filed no later than June 24, 2025.
- 5. Staff shall file its recommendation no later than July 2, 2025.
- 6. This order shall be effective when issued.
