

**MISSOURI GAS ENERGY'S RECONCILIATION**

**Comes now** Missouri Gas Energy ("MGE"), a division of Southern Union Company, by and through counsel, and pursuant to the Commission's scheduling order of January 17, 2001, respectfully submits the following as a reconciliation:

1. A traditional revenue requirement reconciliation has not been prepared or filed at this time due to the submission, on June 12, 2001, by the Staff, Public Counsel and MGE of a First Revised Stipulation and Agreement which proposes to resolve a host of issues, including the standard revenue requirement issues.

2. MGE makes this filing to make the Commission aware that of the two issues known to remain in dispute at this time (class cost of service/class revenue allocations and Public Counsel's low-income fixed credit tariff rate proposal), one of them (Public Counsel's low-income fixed credit tariff rate proposal) may affect the overall revenue increase to result from this case.

3. The filed testimony indicates that implementation of Public Counsel's low-income fixed credit tariff rate proposal would increase MGE's revenue requirement. Public Counsel indicates that this revenue requirement increase would be approximately \$1,851,769. (Colton direct, p. 33) MGE indicates that this revenue requirement increase is not measurable at this time but could range from \$6,153,513 to \$20,888,932. (Cummings rebuttal, pp. 16-19 & Schedule FJC-3)

Wherefore, MGE respectfully submits this reconciliation to the Commission.
