**ORDER SUSPENDING  
POSITION STATEMENTS AND EVIDENTIARY HEARING**

The Missouri Public Service Commission is granting the parties' *Joint Motion For Suspension Of Evidentiary Hearing Schedule And Filing Of Statement Of Positions And Suggested Scheduling For An On The Record Presentation* ("motion"), filed on April 10.<sup>1</sup>

The motion asks the Commission to suspend the:

- Evidentiary hearing on the merits of the applications;<sup>2</sup>
- Filing of position statements.

In support, the parties state that they have reached a settlement in principle, and will file a stipulation and agreement by the week's end, on which they will ask the Commission to decide the applications. Therefore, the Commission will suspend the evidentiary hearing and the filing of position statements.

The parties also suggest that the Commission convene a hearing on the stipulation and agreement<sup>3</sup> to hear presentations in support. The parties suggest times within the dates formerly reserved for the evidentiary hearing. But, until the stipulation and agreement are filed, the Commission will not know whether those dates afford enough time for the Commission to prepare its inquiries. Therefore, the Commission will schedule a hearing on the stipulation and agreement by separate order once the parties file the stipulation and agreement.

**THE COMMISSION ORDERS THAT:**

1. The *Joint Motion For Suspension Of Evidentiary Hearing Schedule And Filing Of Statement Of Positions And Suggested Scheduling For An On The Record Presentation* is granted.
2. The filing of position statements and the evidentiary hearing are suspended.
3. This order is effective immediately upon issuance.
