#### ORDER DIRECTING RESPONSE TO MEDIATION REQUEST

Issue Date: June 6, 2025 Effective Date: June 6, 2025

On May 5, 2025, Michael Perkins filed a complaint with the Missouri Public Service Commission against Missouri-American Water Company (MAWC). On May 6, 2025, the Commission issued an *Order Giving Notice of Complaint, and Directing Staff Response*, which also explained how to request mediation. Mediation is an informal method of dispute resolution in which the parties voluntarily agree to participate. If mediation is unsuccessful, the case returns to the contested case track. No party relinquishes any rights by agreeing to participate in mediation. MAWC filed a request for mediation on June 5, 2025.

The Commission will order Mr. Perkins to state whether he agrees to mediation of the formal complaint.

#### THE COMMISSION ORDERS THAT:

1. No later than June 20, 2025, Michael Perkins shall respond to MAWC's mediation request and state whether he agrees to enter into mediation.

#### 2. This order is effective when issued.
