On Tuesday, June 12, 2001, several parties to this case, not including Intervenor Midwest Gas Users' Association, filed a document entitled "First Revised Stipulation and Agreement." Although no formal notice was included, we are presuming that the document was intended to be filed under 4 CSR 240-2.115.

This letter will serve as the notice stated in 4 CSR 240-2.115(2) that Intervenor Midwest opposes this stipulation, and requests a hearing on all issues comprehended by it under the provisions of the Commission's rule and pursuant to the Missouri Supreme Court's ruling in *State ex rel. Fischer v. Public Service Commission*, 645 S.W.2d 39 (Mo.App. 1982), cert. denied, 464 U.S. 819, 104 S.Ct. 81, 78 L.Ed.2d 91 (1983) and the rulings in *State ex rel. Arkansas Power & Light Company v. Public Service Commission*, 736 S.W.2d 457, 460 (Mo. App., W.D. 1987).
