JOINT MOTION TO SUSPEND PROCEDURAL SCHEDULE


COMES NOW White River Valley Electric Cooperative, Inc. (“White River”), The Empire District Electric Company d/b/a Liberty (“Liberty”) and the Staff of the Commission (the “Staff”) (collectively, the “Parties”), and for their motion to suspend the procedural schedule in this case, respectfully states as follows to the Missouri Public Service Commission (“Commission”):

1. During the Settlement Conference on June 4, 2025, the Parties reached an agreement, in principle, that would settle the above- captioned case. Accordingly, the Parties ask that the Commission suspend the current procedural schedule, including all remaining events (filing of List of Issues, etc., Statements of Positions, the evidentiary hearing, and briefing) to allow the Parties time to produce and file a Stipulation and Agreement consistent with that agreement.

2. The Parties propose that such suspension order further direct the parties to either file such a stipulation and agreement or a status report by June 30, 2025.

WHEREFORE, the undersigned parties unanimously and respectfully ask the Commission to suspend the schedule in these matters as described herein.
