Requests for extension of more than 30 days may be submitted to the Commission before April 15, as provided by 20 CSR 4240-10.145(7). Commission Rule 20 CSR 4240-10.145(7)(B) requires that a copy of the request be sent to all parties of record in pending cases before the Commission where the utility's activities are the primary focus of the proceeding.

The Commission will set a deadline for responses, if any, to Oakbrier Water's extension request. Oakbrier Water's assets are among the assets at issue in File No. WM-2020-0174 now pending before the Commission; the Commission will provide for notice of Oakbrier Water's request to the parties in that case. The Commission will excuse Oakbrier Water's obligation to file an annual report in the interim.

- Oakbrier Water's obligation to file an annual report on or before April 15,
 2020, is excused pending further order of the Commission.
