### ORDER WAIVING 60-DAY NOTICE REQUIREMENT

Issue Date: April 9, 2020 Effective Date: April 9, 2020

On March 30, 2020, Union Electric Company d/b/a Ameren Missouri filed its demand-side program annual report for 2019. Along with its report, Ameren Missouri filed a request for waiver of the 60-day notice requirement of Commission Rule 20 CSR 4240-4.017(1), as it is allowed to do by 20 CSR 4240-4.017(1)(D).

That rule provides that a party may request a waiver for good cause, which specifically includes, among other things, a verified declaration from the filing party that it has had no communications with the office of the commission regarding the substance of the filing within the prior 150 days. Ameren Missouri included such an affidavit with its motion and consequently has demonstrated good cause for waiver of the 60-day notice requirement.<sup>1</sup>

#### THE COMMISSION ORDERS THAT:

1. The 60-day notice requirement of Commission Rule 20 CSR 4240-4.017(1) is waived as applied to Ameren Missouri's filing of its demand-side annual report for 2019.

<sup>&</sup>lt;sup>1</sup> Ameren Missouri may not need a waiver for the filing of its demand-side annual report as the filing may not create a "case" for which a 60-day notice is required. Commission Rule 20 CSR 4240-4.015(1) defines a "case" for purposes of the notice requirement as a matter filed with the Commission for its determination. The Commission is not required to make any determination about Ameren Missouri's demand-side annual report. Hence, this is not a "case" to which the 60-day notice requirement applies. Nevertheless, the Commission will grant the requested waiver.
