## NOTICE ACKNOWLEDGING DISMISSAL

Unice Harris filed a complaint against Evergy Missouri West (Evergy West) on September 18, 2019.<sup>1</sup> On March 27, 2020, Ms. Harris requested this case be dismissed provided she is given 45 days to remedy the balance. Evergy West filed its agreement to provide Ms. Harris' requested 45 days. The Commission considers the agreement offered and accepted, and will issue its notice in accordance with the dates proposed by Evergy West (April 10 to and including May 25 equals 45 days).

Commission Rule 20 CSR 4240-2.116(1) states that a complainant may dismiss a complaint without an order of the Commission before prepared testimony or oral evidence has been offered. The parties have not offered prepared testimony or oral evidence. The Commission, therefore, will take notice of the dismissal. This case is now closed.
