On March 2, 2020, Evergy Missouri Metro and Evergy Missouri West (the Companies) filed an application for modification of their Technical Resource Manuals (TRMs). The Companies want to make changes to their TRMs based on incorporating additional final Evaluation, Measurement, and Verification for the Companies’ program year three of their Missouri Energy Efficiency Investment Act Cycle 2. Staff filed a recommendation to approve that modification on April 9.

The Commission will set a time for responses to Staff’s recommendation and the Companies’ revised technical resource manuals.

**THE COMMISSION ORDERS THAT:**

1. Any responses to Staff’s recommendation or Evergy Missouri Metro and Evergy Missouri West’s revised Technical Resource Manual shall be filed no later than April 14, 2020.
