## ORDER DIRECTING STATUS REPORT

The Commission opened this working case at the request of the Office of Public Counsel to consider a rule regarding the reporting of residential customer disconnection data. The Commission scheduled a workshop meeting to be held on March 30, 2020, to discuss such a rule. That meeting was indefinitely postponed due to the COVID 19 pandemic. Public Counsel and the Commission's Staff filed a status report on April 15 indicating they could not now propose a new date for holding the workshop due to uncertainty about the virus. They ask that they be directed to file a further status report by May 29, 2020. The Commission will do so.

### THE COMMISSION ORDERS THAT:

1. The Commission's Staff and Public Counsel shall file a joint status report no later than May 29, 2020, regarding potential new dates for holding the workshop.
2. This order shall be effective when issued.
