**CONSUMERS COUNCIL OF MISSOURI'S MOTION TO DECLASSIFY
THE REBUTTAL TESTIMONY OF JAMES DITTMER**

COMES NOW the Consumers Council of Missouri ("CCM" or "Consumers Council"), pursuant to 4 CSR 240-2.135, and moves to declassify the rebuttal testimony of James Dittmer pre-filed in this case. In support, Consumers Council states as follows:

1. On January 11, 2015, Consumers Council filed its "Motion To Declassify Historical Surveillance Monitoring Reports And Certain Direct Testimony Discussing Historical Earnings" relating to the historical Ameren Missouri surveillance reports showing the utility's actual earnings from 2012 through September 2014, and for declassification of those portions of the pre-filed direct testimonies of Mr. Greg Meyer and Ms. Lena Mantle, which reference this earnings information. On January 28, 2015, the Commission granted this motion.

2. On January 16, 2015, Consumers Council pre-filed the rebuttal testimony of James Dittmer. Because the Commission had not yet ruled on the classification of a portion of the surveillance reports in question, that portion of Mr. Dittmer's rebuttal testimony that referenced those earnings was redacted. The only portions of Mr. Dittmer's rebuttal testimony that are labelled as highly confidential refer to reports that are now public.

3. Consistent with its previous ruling, Consumers Council asks that the Commission rule that Mr. Dittmer's January 16, 2015 rebuttal testimony may be made public in its entirety.

4. Ameren Missouri has indicated that it does not object to this motion.

WHEREFORE, Consumers Council respectfully requests that the Commission order the declassification of the rebuttal testimony of James Dittmer.
