1. Ordered paragraph No. 2 of the Order Denying Motion to Consolidate, Directing Staff Filing, Setting Time For Responses, and Finding Additional Time Is Needed for a Commission Decision issued on April 15, 2020, is corrected to state:

No later than April 30, 2020, the Staff of the Commission shall file a verified recommendation that provides for the appropriate calculation of the rate adjustments necessary and the method for providing those rate

adjustments in File Nos. GO-2017-0201 and GO-2017-0202. Any request for an extension of time to file the recommendation shall be filed no later than April 24, 2020.
