ORDER DIRECTING NOTICE OF FILING

On April 15, 2020, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) filed its 2019 Renewable Energy Standard (RES) Compliance Report and 2020 Annual RES Compliance Plan, as required by Commission Rule 20 CSR 4240-20.100(8). Additionally, Evergy West requested a variance from 20 CSR 4240-20.100(8)(A)1.I(V) regarding the provision of meter readings used in the calculation of payments to Renewable Energy Credit vendors.

Commission Rule 20 CSR 4240-20.100(8)(D) requires the Commission's Staff to review the Report and Plan and to file a report within 45 days; paragraph (E) of that same rule allows Public Counsel and other interested stakeholders to file comments within that same 45 days. Forty-five days from April 15 is May 30, a Saturday. Commission Rule 20 CSR 4240-2.050(1) allows the parties until the following business day, June 1, to file their report or comments. Any objection to the request for a variance shall also be filed on the

same date. The Commission will direct that notice of this filing be given to potentially interested persons.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order to each party to Evergy Missouri West, Inc. d/b/a Evergy Missouri West's most recent general rate case, File No. ER-2018-0145.

2. The Commission's Data Center shall provide notice of this order to the county commission of each county within Evergy Missouri West, Inc. d/b/a Evergy Missouri West's service area.

3. The Commission's Public Policy and Outreach Office shall make notice of this order available to the members of the General Assembly representing Evergy Missouri West, Inc. d/b/a Evergy Missouri West's service area, and to the news media serving its service area.

4. Any objection to the request for a variance shall be filed no later than June 1, 2020.

5. This order shall be effective when issued.
