Twin Valley Communications, Inc. (Twin Valley) filed notice on April 13, 2020, requesting the Commission cancel its certificates of service authority to provide basic local, non-switched local, and interexchange telecommunications services. Twin Valley states it does not currently have a tariff. The Commission will direct its Staff to file a recommendation regarding the requested cancellation.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a recommendation regarding the request to cancel its certificates of service authority filed by Twin Valley Communications, Inc. no later than June 1, 2020.
2. This order shall be effective when issued.
