STAFF RECOMMENDATION

COMES NOW the Staff of the Public Service Commission of Missouri and recommends:

- 1. On June 26, 2001, Missouri Gas Energy, the Office of the Public Counsel, the Staff, Midwest Gas Users' Association, Jackson County, and the City of Riverside filed a Second Revised Stipulation and Agreement in this case. The Stipulation resolved all issues raised in the case, and the parties asked the Commission to put the stipulated rates into effect for service rendered on and after August 6, 2001.
- On July 5, 2001, the Commission entered its order approving the Second Revised Stipulation and Agreement.
- On July 16, 2001, MGE filed tariff sheets in compliance with the Commission's order approving the Stipulation. MGE filed substitute tariff sheets on July 31, 2001, to correct typographical errors.
- 4. The Commission's Energy Department Staff has reviewed the tariffs, and finds that they are in compliance with the Commission's order approving the Stipulation. The Staff's review, including a listing of the tariff sheets at issue, is attached as Attachment 1 hereto.



The Staff further finds that good cause has been shown under section 393.140(11) RSMo 2000, to approve these tariff sheets on less than 30 days notice. The Staff recommends that the Commission approve the tariff sheets, effective for service on and after August 6, 2001.

5. WHEREFORE, the Staff recommends that the Commission approve MGE's compliance tariff sheets, effective for service on and after August 6, 2001.

Purpose:

Compliance Filing in Case No. GR-2001-292

On July 16, 2001, Missouri Gas Energy, A division of Southern Union Company (MGE or Company) filed tariff sheets bearing a proposed effective date of August 15, 2001. However, MGE requested an effective date of August 6, 2001 to comply with the Commission's Order Approving Second Revised Stipulation and Agreement. On July 31, 2001 MGE filed substitute tariff sheets to correct typographical errors.

These tariffs were filed to comply with the Commission's Order Approving Second Revised Stipulation and Agreement (Order). This Order provides that MGE should be authorized to receive a revenue increase in the amount of \$9,892,228 exclusive of funding for the experimental low-income rate proposed in the stipulation and agreement, and exclusive of gross receipts taxes or taxes or fees of a similar nature. The stipulation and agreement contains numerous other provisions to resolve disputed issues between the parties, including a provision requiring that MGE's rate increase should go into effect no later than August 6, 2001.

The Commission's Energy Department Staff has reviewed this filing and is unaware of any issue currently pending before the Commission that affects or is affected by this filing. Staff is of the opinion that good cause for approval of these tariff sheets on less than thirty (30) days notice is demonstrated by the Commission's Order which states the MGE is authorized to file tariffs "effective for services rendered on and after August 6, 2001." Staff therefore recommends approval of the following tariff sheets, as filed on July 16, 2001 and substituted on July 31, 2001 with an effective date of August 6, 2001:
