On April 21, 2020, Spire Missouri, Inc. d/b/a Spire (Spire) submitted an application requesting financing authorization in the amount of \$750 million through September 30, 2023. Spire also requests waiver of the 60-day notice requirement under Commission Rule 20 CSR 4240-4.017.

The Commission will direct the Staff of the Missouri Public Service Commission (Staff) to file a recommendation regarding Spire's application.

THE COMMISSION ORDERS THAT:

1. No later than June 22, 2020, Staff shall file a recommendation regarding Spire's application requesting financing authorization in the amount of \$750 million.
2. This order shall be effective when issued.
