## ORDER DIRECTING RESPONSES TO REQUEST FOR EXTENSION OF TIME

On April 10, 2020, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) submitted an application requesting authority to issue debt securities in response to the economic impact of the COVID-19 pandemic. Evergy Metro seeks a Commission order no later than May 11, 2020<sup>1</sup>.

The Commission directed an expedited recommendation from the Staff of the Missouri Public Service Commission (Staff). Staff requested an extension to May 1, to allow time to receive responses from Evergy Metro to Staff's data requests. A delay in the Staff recommendation to May 1, would not allow for a May 11 effective date. Commission orders issued at the scheduled May 6 Agenda meeting would likely have an earliest effective date of May 16.

The Commission will direct Evergy Metro to respond to Staff's request for an extension.
