## ORDER GRANTING, IN PART, STAFF'S MOTION FOR AN EXTENSION OF TIME

Effective Date: April 24, 2020

On April 15, 2020, the Commission directed its Staff to file a verified recommendation providing calculations of rate adjustments to comply with the Court of Appeals' mandate. On April 22, 2020, Commission Staff filed a request for additional time to file its recommendation. The Commission will grant an extension of time, but not for the entire 30-days.

### THE COMMISSION ORDERS THAT:

1. No later than May 15, 2020, the Staff of the Commission shall file a verified recommendation that provides the calculation of the amount of the ineligible plastic mains and service lines according to the methodology used in File Nos. GO-2016-0332 and GO-2016-0333, the calculation of the rate adjustments necessary, and the method for providing those rate adjustments.

2. Any responses to the Staff's recommendation shall be filed no later than ten days after Staff's recommendation is filed.

3. This order is effective when issued.
