## ORDER SETTING PREHEARING CONFERENCE

On February 24, 2020, Barbara Edwards filed a complaint with the Commission against Evergy Metro, Inc. d/b/a Evergy Missouri Metro. Evergy Missouri filed its answer. The Commission's Staff filed a report on April 27, 2020.

This matter is ready to be set for hearing. The Commission will set a prehearing conference to discuss a hearing date, other procedural issues and the possibility of settlement before hearing. Because of the closure of state government buildings in response to the COVID-19 pandemic at the time of this order, the conference will be conducted by telephone.

### THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference at 1:15 p.m. on May 19, 2020. Failure to appear at the conference without being excused may result in dismissal of the complaint and/or dismissal of a party, as permitted by Commission Rule 20 CSR 4240-2.090(5).

2. The prehearing conference will be conducted by telephone conference call.
