On February 24, 2020, Barbara Edwards filed a complaint with the Commission against Evergy Metro, Inc. d/b/a Evergy Missouri Metro. Evergy Missouri's answer, filed on March 26, 2020, indicates Ms. Edwards is a customer of Evergy Missouri West, Inc. d/b/a Evergy Missouri West. Staff's report, filed on April 27, 2020, confirms this conclusion.
