ORDER DIRECTING THE PARTIES TO FILE A LIST OF ISSUES NO LONGER IN DISPUTE

On May 6, 2020, the parties submitted initial briefs, and answers to Commission questions. However, the May 6, 2020, filings display a lack of clarity as to what issues are no longer in dispute. Some parties indicate that issues are undisputed that other parties indicate are still in dispute. The Commission will order the parties to jointly file a stipulation regarding any undisputed issues. Undisputed issues are issues that are undisputed irrespective of Commission action on any other issues.

THE COMMISSION ORDERS THAT:

1. No later than May 11, 2020, the parties shall file a stipulation containing any issues no longer in dispute and the agreed upon solutions to those issues.
2. This order is effective when issued.


