## ORDER REGARDING MOTION FOR PROTECTIVE ORDER

White River Valley Cooperative, Inc. filed an application on February 19, 2025 pursuant to RSMo 386.800.3 and 20 CSR 4240-20.045, for an Order Approving Designated Service Boundaries. On February 19, 2025 White River Valley Electric Cooperative also filed a *Motion for a Protective Order* citing 20 CSR 4240-2.135(2). On April 23, 2025 White River filed an *Amended Motion for a Protective Order* requesting that information contained in its feasibility study and designated as Appendix E to White River's Application and Schedule RJ-03 to the Direct Testimony of Rick Johnson be designated highly confidential. The rule cited by the Applicant requires the information requested in the Motion should be filed in EFIS and that information has been filed in EFIS. No party has objected to the filing of the Motion. The Commission shall grant the requested information a highly confidential designation.

1. The Commission will grant the Amended Motion for Protective Order.
