## ORDER CANCELLING HEARING DATE

White River Valley Cooperative, Inc.(White River) filed an application on February 19, 2025 pursuant to RSMo 386.800.3 and 20 CSR 4240-20.045, for an Order Approving Designated Service Boundaries. On April 14, 2025 an Order designating time lines for Procedural Schedules was issued and on April 18, 2025, a Joint Procedural Schedule was filed. On June 6, 2025 the Parties filed a *Joint Motion to Suspend the Procedural Schedule* as they have reached a Settlement Agreement. The Parties requested the Commission give them until June 30, 2025 to either submit a stipulation or agreement or a status report.

Because the Parties have requested the suspension of the Procedural Schedule, the Commission will cancel the hearing scheduled for July 7, 2025 at 9:00 a.m.

1. The hearing date scheduled for July 7, 2025 is cancelled.
