ORDER REQUIRING EXPEDITED FILING

On May 13, 2020,¹ the Commission issued its Order Approving Stipulation and Agreement. This order approved the Unanimous Stipulation and Agreement the parties filed on April 14, rejected the tariff sheets Spire Missouri, Inc. (Spire), filed on February 13, Tariff Tracking Numbers YG-2020-0139 and YG-2020-0140, and ordered Spire to file compliance tariff sheets conforming with the approved Stipulation and Agreement no later than May 23.

On May 13, Spire filed revised sheets YG-2020-0197 (Spire East) and YG-2020-0198 (Spire West) and Motions for Expedited Treatment. Spire's motions state their purpose is to allow the revised sheets to become effective on May 25 and within the 120-day time period mandated by the ISRS Statute. Spire states that Commission approval will cause no negative impact on customers or the general public.

The Commission will order Staff to file a recommendation on whether the revised tariff sheets comply with the May 13 order approving the Stipulation and Agreement and set a deadline for the Office of Public Counsel and other parties to file objections or comments concerning the revised tariff sheets.

THE COMMISSION ORDERS THAT:

1. No later than noon on May 15, 2020, the Commission Staff shall file its recommendation concerning whether revised tariff sheets YG-2020-0197 (Spire East) and YG-2020-0198 (Spire West) comply with the Commission's May 13, 2020, Order Approving Stipulation and Agreement and should be approved to go into effect.
2. Any objection or comment on the revised tariff sheets from the Office of Public Counsel and any other party shall be filed no later than noon on May 15, 2020.
3. This Order shall be effective when issued.
