## NOTICE REGARDING PRESENTATION TO COMMISSION

Issue Date: May 18, 2020

On May 24, 2018, the Commission issued a Report and Order that approved a stipulation and agreement which contained certain merger commitments and conditions. Condition No. 37(a) states, in part, that Kansas City Power & Light Company (now known as, “Evergy Missouri Metro”) and KCP&L Greater Missouri Operations Company (now known as “Evergy Missouri West”) agree to appear before the Commission and provide an update on the status of the merger integration implementation and an opportunity for the Commissioners to ask questions about that implementation.

The Commission will convene an informal proceeding for those companies to provide its biannual status report on the merger implementation immediately following the Commission’s regularly-scheduled agenda meeting on June 10, 2020. The proceeding will be held via WebEx video and telephone conference, and will be webcast live on the Commission’s website at [www.psc.mo.gov](http://www.psc.mo.gov). The proceeding will not be transcribed, and no time will be allocated for questions or comments from other parties or interested persons.
