On February 21, 2020,¹ the Commission issued an Order Adopting Procedural Schedule (procedural schedule) and setting the case for an evidentiary hearing on May 28. On May 7, the Manager of the Manufactured Homes and Modular Units Program (Manager) filed an Expedited Request for Prehearing Conference, asking for a conference to determine how "to receive live testimony from two or three witnesses [who] did not submit prefiled testimony." On May 11, the Commission ordered the parties to file suggestions no later than May 14 addressing whether the procedural schedule allows the Manager to present such testimony. On May 14, the parties filed a Response to May 11, 2020 Order. Therein, the parties stated they believed the procedural schedule does not allow testimony from witnesses who did not submit prefiled testimony. The

parties also advised the Commission they were hopeful the case would settle. If it does not, the parties stated they would likely request the procedural schedule be suspended and propose a new one in order to receive additional testimony from homeowners and other witnesses. For purposes of administrative efficiency and economy in preparation for the hearing, the Commission will order the parties to file a status report.

THE COMMISSION ORDERS THAT:

- 1. No later than May 21, 2020, the parties shall file a status report addressing the matters described in the body of this order.
 - 2. This order shall be effective when issued.
