## ORDER EXTENDING TIME TO FILE PROPOSED SCHEDULE

Issue Date: May 20, 2020

Effective Date: May 20, 2020

On January 16, 2020, Claude Scott filed a complaint with the Commission against Spire Missouri, Inc., d/b/a Spire. After the Commission issued notice, Spire requested mediation. When the case was not resolved in mediation, Spire filed its answer. The Commission's Staff filed a report on April 20, 2020.

A prehearing conference was conducted on May 11, 2020, with all parties present to discuss a hearing date, other procedural issues, and the possibility of settlement. During the conference, Staff counsel was directed to file a proposed procedural schedule, in consultation with the parties, no later than May 21, 2020.

On May 20, 2020, Spire filed a status report indicating efforts now underway to resolve Mr. Scott's complaint. Spire requests an extension of time to file a proposed procedural schedule to allow the parties an opportunity to complete discussions. The Commission will grant the request for extension.

### THE COMMISSION ORDERS THAT:

1. Staff shall file a proposed procedural schedule no later than June 4, 2020.

2. The Commission's data center shall mail a copy of this order by U.S. Mail addressed to Complainant at Complainant's address of record.

3. This order shall be effective when issued.
