ORDER REGARDING ELECTRONIC HEARING PROCEDURES AND SETTING A TECHNOLOGY PRACTICE SESSION

An evidentiary hearing in this matter is set for May 26-27, 2020. Due to the current COVID-19 pandemic, this hearing will be held by electronic means via WebEx video and teleconference rather than in person at the Commission's offices as currently scheduled. In order to do so, the parties will be required to provide all exhibits and presentations they intend to use in an electronic format to the Regulatory Law Judge and all parties prior to the hearing. This includes any rebuttal exhibits that may be used during cross-examination if they are known.

The Commission will also set a technology practice session to give the parties and the Regulatory Law Judge a chance to practice using the technology before the hearing and to discuss other technical issues. No substantive discussions will take place and this conference will not be conducted on the record.

THE COMMISSION ORDERS THAT:

1. The evidentiary hearing scheduled for May 26-27, 2020, shall be held by video and teleconference via WebEx. Participants shall appear at the evidentiary hearing telephonically via WebEx video and telephone conference. The hearing will also be live-streamed via the Commission's website at psc.mo.gov. Interested persons who will not be actively participating in the hearing should access the hearing via the live stream. The link and access code to participate in the hearing via WebEx conference call will be emailed to all parties.
2. All exhibits and presentations that any party intends to use at the hearing shall be emailed to the Regulatory Law Judge and counsel for each party no later than 8:30 a.m. on May 26, 2020.
3. An informal WebEx video and telephone conference is set at 10:45 a.m. on May 22, 2020, for the purposes set out in the body of this order. The link and access code to participate in the technology practice session via WebEx will be emailed to all parties.
4. This order is effective when issued.
