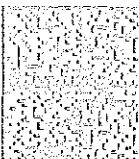

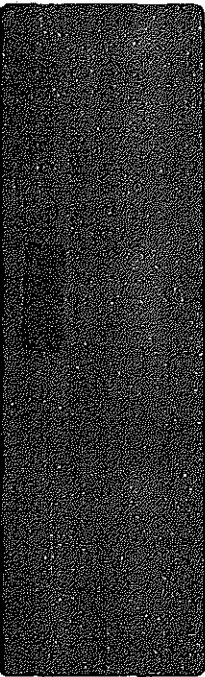

**ORDER DENYING APPLICATIONS FOR REHEARING OF  
REPORT AND ORDER**

On September 2, 2015, the Missouri Public Service Commission issued a Report and Order effective September 15, 2015, regarding Kansas City Power & Light Company's tariffs designed to implement a general rate increase for electric utility service. On September 11, 2015, the Office of the Public Counsel filed an application for rehearing. Kansas City Power & Light Company, Consumers Council of Missouri, and Midwest Energy Consumers Group filed applications for rehearing on September 14, 2015.

Section 386.500.1, RSMo 2000, states that the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, none of the parties filing applications for rehearing have shown sufficient reason to rehear the matter. The Commission will deny the applications for rehearing.

**THE COMMISSION ORDERS THAT:**

1. Kansas City Power & Light Company's Application for Rehearing is denied.
2. The Office of the Public Counsel's Application for Rehearing is denied.

3. Midwest Energy Consumers Group's Application for Rehearing/Reconsideration is denied.
4. Consumers Council of Missouri's Application for Rehearing is denied.
5. This order shall be effective when issued.


