On February 6, 2020, Liberty Utilities (Missouri Water) LLC filed an application with the Missouri Public Service Commission requesting that the Commission approve its acquisition of the water and sewer franchises and assets of Lakeland Heights Water Company, Oakbrier Water Company, R.D. Sewer Company LLC, and Whispering Hills Water System.

Thereafter, the Commission directed the Staff of the Commission (Staff) to file a recommendation. Staff timely filed a request for additional time on March 24, 2020, which was granted, making the recommendation due on May 25, 2020. Staff now moves for an additional ten days to finalize its recommendation.

Staff states that it contacted the other parties and none objected to its requested extension. Based on the representation of counsel, the Commission will consider the request for additional time unopposed. The Commission finds that the unopposed request for additional time is reasonable and will grant it.

- 1. The *Motion For Further Extension*, filed by the Staff of the Commission on May 21, 2020, is granted.
- 2. The Staff of the Commission shall submit its recommendation no later than June 4, 2020.
