ORDER FURTHER SUSPENDING TARIFF

On November 25, 2019, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed an Application for Approval to Expand Community Solar Pilot Program and Associated Tariff. At Staff's request, the Commission suspended the tariff first until March 25, 2020, then until April 24, 2020, and again until May 25, 2020.

On May 13, 2020, the parties filed a unanimous stipulation and agreement that purports to resolve all issues. That agreement calls for the rejection of the Ameren Missouri tariff and indicates upon approval of the agreement Ameren Missouri will file a new tariff. The Commission has not yet approved the agreement.

On May 22, 2020, Staff file a recommendation advising the Commission to further suspend the original tariff to avoid having it go into effect before the agreement can be addressed. Staff represents that all parties agree the tariff should be suspended. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The following tariff sheet filed by Union Electric Company d/b/a Ameren Missouri on November 25, 2019, and assigned Tariff File No. YE-2020-0091, are suspended until June 24, 2020, or until otherwise ordered by the Commission:
