On January 16, 2025, Jim Moriarty filed a complaint against Missouri-American Water Company. On May 14, 2025 Staff filed a recommendation. Pursuant to a June 2, 2025 Order, on June 3, 2025, Complainant, and on June 9, 2025, Staff Counsel filed Procedural Schedules.

The Commission will now Order a Procedural Schedule requiring testimony and exhibits to be filed by August 14, 2025 and the Evidentiary Hearing date shall be August 28, 2025.
