ORDER GRANTING FURTHER EXTENSION OF TIME

On January 28, 2025,¹ Summit Natural Gas of Missouri, Inc. (SNGMO) submitted an application requesting authority to participate in a Money Pool that would be organized for itself and its affiliates.

The Staff of the Commission (Staff) was directed to file a recommendation or status report no later than March 3, later extended to May 2, June 2, and June 17. On June 16, Staff and SNGMO jointly filed a request for an extension of time to submit Staff's recommendation, a status report, or a stipulation and agreement.

The joint request indicates Staff and SNGMO have communicated regarding the proposed money pool, and agreed on a draft stipulation and agreement to resolve this matter. The filing also indicates that the Office of the Public Counsel (OPC) has recently received a copy of the draft stipulation and issued a request for information. Also, a technical conference was held among all three parties to the case -- SNGMO, Staff, and OPC -- which resulted in Staff issuing supplemental data requests.

The request is for a short extension of time to review OPC's suggestions to the draft stipulation and for SNGMO to provide responses to Staff's supplemental data

requests. The request would extend the date to file Staff's recommendation, a further status report, or a stipulation and agreement to July 17. The Commission finds the request for an extension of time reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. No later than July 17, 2025, Staff shall file a stipulation and agreement, a recommendation, or a further status report.
2. This order shall be effective when issued.
