ORDER DIRECTING A STAFF TARIFF RECOMMENDATION AND SETTING TIME FOR OTHER COMMENTS OR OBJECTIONS

On June 13, 2025, The Empire District Electric Company d/b/a Liberty filed a proposed tariff revision, Tracking No. JE-2025-0176, which bears an effective date of August 1, 2025. Liberty's tariff revision is an additional true-up outside of its required annual true-up. Liberty states that this additional true-up is necessary because Liberty is anticipating lower electric usage for the last quarter of 2025.

The Commission will direct its Staff (Staff) to file a recommendation about the tariff sheet, and will set a time for filing any other comments or objections.

THE COMMISSION ORDERS THAT:

1. Staff must file a recommendation about Liberty's tariff sheet no later than July 2, 2025.
2. Any other comments or objections about Liberty's tariff sheet must be filed no later than July 2, 2025.

3. This order is effective when issued.
