## ORDER CANCELING EVIDENTIARY HEARING AND DISMISSING APPLICATION FOR CHANGE OF ELECTRIC SUPPLIER

Issue Date: June 20, 2025

Effective Date: June 30, 2025

On June 16, 2025, Michael Davis filed a motion to dismiss his application for a change of supplier from Ozark Electric Cooperative, Inc. to The Empire District Electric Company d/b/a Liberty.

Commission Rule 20 CSR 4240-2.116(1) states that once prepared testimony has been filed, an applicant may only dismiss an application by leave of the Commission. Prepared testimony was filed and an evidentiary hearing was set to begin on July 1, 2025. However, Mr. Davis no longer wishes to prosecute this case. Therefore, the Commission will grant him leave to dismiss his application for a change of supplier and cancel the evidentiary hearing. So, this order is effective prior to the start of the evidentiary hearing, the Commission finds it reasonable to make this order effective in less than 30 days.

### THE COMMISSION ORDERS THAT:

1. The Commission grants leave to Mr. Davis to dismiss his change of supplier application.
2. Mr. Davis' motion to dismiss is granted.

3. The evidentiary hearing set for July 1, 2025, is canceled.
4. This order shall be effective on June 30, 2025.
5. This file shall be closed on July 1, 2025.
