On May 6, 2020, Evergy Metro Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively "Evergy") applied for an accounting authority order to govern costs and financial impacts associated with the COVID-19 pandemic.

On May 11, 2020, Midwest Energy Consumer's Group (MECG) filed an application to intervene. MECG opposes Evergy's request for an accounting authority order; MECG's application contends allowing MECG to intervene will serve the public interest by assisting the record for the Commission's decision in this case.

On May 15, 2020, Renew Missouri Advocates d/b/a Renew Missouri filed an application to intervene. Renew Missouri's application contends allowing Renew Missouri to intervene will serve the public interest by assisting the record for decision in this case.

More than 10 days have passed since MECG and Renew Missouri applied to intervene; no party has objected to either application.

The Commission will grant the applications to intervene based on a determination

that intervention will serve the public interest.¹

- 1. MECG's and Renew Missouri's applications to intervene are granted.
- 2. This order shall be effective when issued.
