## ORDER RECOGNIZING NAME CHANGE

Issue Date: May 27, 2020

Effective Date: June 26, 2020

IAMO Telephone Company submitted a letter dated May 18, 2020, advising that it has changed its name to IAMO Communications, Inc. The company has also filed an updated tariff to reflect the new name.<sup>1</sup> That tariff carries an effective date of May 28, 2020. The Commission's Staff filed a recommendation on May 27, indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

### THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of IAMO Telephone Company to IAMO Communications, Inc.
2. The revised tariff filed by IAMO Communications, Inc. (Tariff No. YI-2020-0203) will be allowed to take effect on May 28, 2020.
3. This order shall be effective on June 26, 2020.
