## ORDER ADDRESSING CONFIDENTIALITY DESIGNATION

Issue Date: May 27, 2020

On May 26, 2020, the Office of the Public Counsel (Public Counsel) filed a motion challenging an aspect of the confidentiality designation of Appendix M of the application of Missouri-American Water Company.<sup>1</sup> Appendix M is a Private Letter Ruling (PLR) issued by the Internal Revenue Service. The PLR is publicly available on the IRS website as PLR number 202010002. Public Counsel requested that the Commission find that fact to be non-confidential.<sup>2</sup>

Public Counsel requested expedited responses and an expedited decision by the Commission as the evidentiary hearing in this matter is scheduled for June 3, 2020.

On May 27, 2020, Missouri-American Water Company responded that it does not object to the specific, limited relief requested by Public Counsel. No other parties responded in the shortened time frame allotted.

**THE COMMISSION ORDERS THAT:**

1. The information that publicly available PLR 202010002 is the publicly available version of Appendix M in Missouri-American's application, and Schedule JRW-2 of John R. Wilde's direct testimony, is non-confidential.
2. This order shall be effective when issued.
