### NOTICE OF DEFICIENCY

Issue Date: May 28, 2020

On May 27, 2020,<sup>1</sup> Union Electric Company, d/b/a Ameren Missouri (Ameren or Company), filed an application (Application) seeking authority to sell, transfer, and otherwise dispose of a portion of the Company's franchise, works, or system to three Rivers Electric Cooperative (Three Rivers). Additionally, Ameren and Three Rivers jointly applied for an order authorizing the transfer to Ameren of 270 customers currently receiving retail service from Three Rivers and the transfer to Three Rivers of 258 customers currently receiving retail service from Ameren Missouri. Additionally, Ameren and Three Rivers jointly applied for authority establishing exclusive service territories for them in portions of Missouri counties of Cole and Osage.

The Application was not accompanied by a filing fee. Rule 20 CSR 4240-3.130(3) states the application for approval of electric service territorial agreements "shall be accompanied by an initial filing fee in the amount of five hundred dollars (\$500)." This rule is authorized by Section 394.312.8, RSMo.<sup>2</sup>
