## ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: May 28, 2020

Effective Date: June 7, 2020

On May 22, 2020, Summit Natural Gas of Missouri Inc. (Summit) filed compliance Tariff No. YG-2020-0205, pursuant to the Commission's Order Granting Certificates of Convenience and Necessity and Waiver (Order) issued May 6, 2020. The Order required Summit to update its tariff to incorporate the expanded service areas in Laclede and Webster Counties. The tariff has an effective date of June 21, 2020; however, Summit requested the Commission approve the tariff sheets to be effective June 5, 2020.

The Staff of the Missouri Public Service Commission (Staff) responded on May 28, 2020, that the tariff revision complies with the Commission's Order, and recommended that the Commission approve the compliance tariff sheets. After reviewing the tariff sheets and Staff's statement concerning the compliance tariff sheets, the Commission finds that Summit's tariff complies with the Commission's order granting a Certificate of Convenience and Necessity, and will approve it.

Staff did not oppose Summit's request for an effective date in less than 30 days. As the request is unopposed, and so that this compliance tariff may go into effect close to the requested effective date, the Commission will make this order effective in ten days.

1. The tariff sheet filed by Summit on May 22, 2020, assigned Tracking No. YG-2020-0205 is approved to become effective on June 7, 2020. The approved tariff sheets are:
